## **TECHNICAL ADVISORY COMMITTEE MEETING** MARCH 14, 2024 AT 9:00 AM VIA ZOOM

## SUMMARY

- 1. INTRODUCTION AND ANNOUNCEMENTS
  - Participants made self-introductions, a list of attendees follows.
  - Fred Meyer announced public meeting for Zanker Project for Friday, March 22, 2024 at 10am at CDFW.
  - Suzanne Deleon announced FRGP is out and the concept proposal phase is closed, if need to submit full proposal it will need to be turned by April 18<sup>th</sup>.
  - Chris Guptill announced the boat launch in Modesto is close to being complete. On Saturday, March 23<sup>rd</sup> a Recreation Festival is taking place at 9<sup>th</sup> St Bridge from 9am-2pm. Clean Up Event is scheduled for April 13<sup>th</sup>. This will mark the 100<sup>th</sup> cleanup for the 9-99 operation. They hope to have a celebration in May.
  - Pat Maloney announced he had 38 classrooms with 90 salmon each and had one class lose 4 fish.

Follow up meeting suggested for pulse flow scheduling. Gretchen suggested to have one meeting to address the flow schedule and Cottonwood ramp down.

  - Pat Maloney shared the Basin Index, the Annual Fish Flow Volume and the Fall Flow Schedule noting it will not be final until April 15, 2024. Discussion followed.
